- Typed in a single column left justified; 10 or 12 Characters Per Inch
- Two blank lines between each creditor name/address
- Handwritten is also acceptable if pro se (no attorney)

- * Form 201 Voluntary Petition for Non-Individuals Filing for Bankruptcy (and Form 201A if applicable)
- * Form 204 List of Creditors Who Have the 20 Largest Unsecured Claims Against You Who Are Not Outsiders

The below are REQUIRED to be filed with the petition **OR** within <u>**14 days**</u> thereafter or case may be dismissed. **Exception:** Application to Employ (21 days)
